University of the Sunshine Coast - UniSC Student Services and Amenities Fee (SSAF) 2022 Allocation Report

The Higher Education Support (Student Services, Amenities, Representation and Advocacy) Guidelines 2022 require higher education providers to provide a publicly available report on student services and amenities fee (SSAF) allocations and actual expenditure for the year as part of their annual reporting and in the form approved by the Minister. This SSAF Allocation Report is the form approved by the Minister.

Additional reporting was introduced to allow for greater transparency and consistency in SSAF allocations and expenditure.

Please note, the information provided in this *SSAF Allocation Report* does **not** require auditing by a financial accountant. The SSAF <u>expenditure reporting remains unchanged</u>, more information can be found in the <u>Financial Statements Guidelines</u> for Table A and B providers, and in the <u>Financial Viability Instructions: Applicants and Providers of FEE-HELP (FVI)</u> for all other approved providers.

SSAF Consultation and Achievements

UniSC's SSAF allocation process is managed via the Pro Vice-Chancellor (Students). This process includes extensive consultation with students and staff across the University. The Student Representative Council (SRC) performs an annual review of services with suggestions on areas for SSAF to be allocated. This is reviewed by the PVC(S) prior to any allocation being approved. A Campus Life Committee was also established at the University to hear direct feedback from students on how to enliven the UniSC campuses. This consultation also leads to proposals for SSAF funding.

Outline of 2022 consultation process

- 1. UniSC Student Guild, Student Senate, and other student groups invited to review current initiatives and propose new SSAF priorities.
- 2. Student feedback reviewed by Student Guild, Student Senate, and PVC (Students) and recommendations made for 2023.
- 3. Priorities then published on SSAF information web page.
- 4. Students and student groups are also encouraged to provide views on the current year SSAF expenditure, and submit proposals, at any time via email to the Director, Student Services and Engagement. Feedback received through this avenue will be considered as part of the consultation for the following year's SSAF allocation.

2022 SSAF Priorities

- 1. Advocacy and welfare
- 2. Academic skills and online academic support
- 3. Campus amenities and comfortable study space
- 4. Campus life and sporting facilities
- 5. Career development and employability
- 6. Student governance and leadership
- 7. Student wellbeing and accessibility
- 8. Subsidised food and services

It is noted that from 2023, a SSAF Advisory Committee at UniSC has been established. The SSAF Advisory Committee is to function as a broad, representative, and consultative group of staff and students members that reviews SSAF allocations and applications on behalf of the Pro Vice-Chancellor (Students).

- The Pro Vice-Chancellor (Students) serves as Chairperson.
- The Pro Vice-Chancellor (Students) will approve or decline SSAF allocations on behalf of USC.
- Approved allocations will be reported at Campus Life Committee meetings.

2022 SSAF Funded activities – highlights

- Delivery of major transition events including Orientation and Connect Week across five campuses.
- On campus subsidised food scheme to support financial welfare, while providing healthy affordable food items.
- Delivery of the Higher Degree by Research (HDR) Student Experience Mentor program.
- Delivery of several Student Engagement Campaign's that successfully supported early engagement and just in time support for new students.

- High performance Student Athlete Bursary program offering an offset to offset the costs associated with successfully balancing high performance sporting commitments with higher education at UniSC.
- The UniSC Student Guild provided high quality welfare support, social events and advocacy to students enrolled at UniSC.
- Continued expansion of UniSC's Student Senate Framework.
- Regular student engagement and events/activities across all campuses, supporting a sense of belonging for new and continuing students.
- UniSC Sport's Engagement and retention of students through offerings to support wellbeing and a sense of belonging to the UniSC community

¹ Note: As per Part 2 of the *Higher Education Support (Administration) Guidelines 2022* (Administration Guidelines), students studying on a part-time basis must not be charged more than 75 per cent of the maximum SSAF that a higher education provider determines for students studying on a full-time basis. The term "part-time basis" means a study load of less than 75 per cent of the normal full-time student load for the period to which the fee relates. As per part 7 of the Administration Guidelines, the normal EFTSL value for a full-time student studying over a period of one year is 1.0.

UniSC is largely a face-to-face educational facility, with only a small percentage (approximately 10% of its students), studying their programs remotely. These students have full access to all SSAF services should they choose, and frequently are supported throughout their studies by SSAF funded initiatives.
