The Higher Education Support (Student Services, Amenities, Representation and Advocacy) Guidelines 2022 require higher education providers to provide a publicly available report on student services and amenities fee (SSAF) allocations and actual expenditure for the year as part of their annual reporting and in the form approved by the Minister. This SSAF Allocation Report is the form approved by the Minister.

Additional reporting was introduced to allow for greater transparency and consistency in SSAF allocations and expenditure.

Please note, the information provided in this *SSAF Allocation Report* does **not** require auditing by a financial accountant. The SSAF <u>expenditure reporting remains unchanged</u>, more information can be found in the <u>Financial Statements Guidelines</u> for Table A and B providers, and in the <u>Financial Viability Instructions: Applicants and Providers of FEE-HELP (FVI)</u> for all other approved providers.

SSAF Consultation and Achievements

Compliance:

In 2023, the University's SSAF allocation process was managed through the SSAF Advisory Committee, chaired by the Pro Vice-Chancellor (Students). The Committee's activities and decisions were conducted in line with the Higher Education Support Act 2003 - Student Services, Amenities, Representation and Advocacy Guidelines.

Membership of the Advisory Committee included:

- 1. Pro Vice-Chancellor (Students) (Chair)
- 2. Pro Vice-Chancellor (Global and Engagement)
- 3. Pro Vice-Chancellor (Aboriginal and Torres Strait Islander Strategy)
- 4. Academic Registrar and Director, Student Services
- 5. Dean of Graduate Research
- 6. Senior Accountant, Financial Services
- 7. Postgraduate Student Representative
- 8. Undergraduate Student Representative
- 9. Student Equity, Diversity and Engagement Coordinator (Secretariat) (Non-voting)

The majority of allocations for 2023 were determined across two meetings held in December 2022. Quarterly meetings were also scheduled throughout 2023 to consider urgent or emerging funding requests.

All funding requests were assessed in accordance with the in accordance with subsection 19-38(4) of the *Higher Education Support Act 2003* (HESA).

Student consultation

In August 2022, the Student Senate conducted its annual SSAF Survey, which was distributed to all enrolled UniSC students. The survey sought to understand students' use of SSAF-funded services across the funded period, and to ascertain their perceptions of the priorities for funding over the coming year.

The survey received a total of 508 responses and identified eight key areas of investment for SSAF funding, ordered in priority by respondents:

- 1. Academic skills and online academic support
- 2. Student wellbeing services
- 3. Subsidised food and services
- 4. Student Guild activities, campus life, advocacy and welfare

- 5. Campus amenities and comfortable study spaces
- 6. Careers and development and employability
- 7. Student governance and leadership
- 8. AccessAbility services

A report of survey findings was shared with the SSAF Advisory Committee, to support decision making towards 2023 allocations.

The report was also distributed to relevant University and Student Guild staff to inform 2023 SSAF requests.

Direct student consultation was provided to the SSAF Committee via two nominated student representatives, who held full voting rights.

2023 SSAF Funded activities - highlights.

- Access to academic skills advice through UniSC's Peer Learning Advisor program was expanded, with an additional 772 individual appointments offered across 2023. In addition, all UniSC students were provided with access to responsive, just-in-time assignment feedback and learning support via the University's partnership with Studiosity.
- SSAF funding subsidised onsite food offerings across all campuses through a variety of
 initiatives targeted to meet the needs of local student cohorts, including subsidised
 meals, student kitchens and snack bars. These offerings focused on providing
 affordable, nutritious food at low or no cost to promote physical and financial
 wellbeing.
- The Student Guild delivered an extensive program of events and engagement activities across all campuses, along with welfare services in the form of community partnership donations, drop-in food collection, frozen meals, emergency foodbank provisions (including grocery gift cards for students unable to collect from campus), and tenancy referrals). In addition, the Guild's advocacy service supported 663 individual matters related to university policy or procedures (such as Review of Final Grade or Withdrawal Due to Special Circumstance), a 29 percent increase on the previous year.
- The University's SSAF-funded student flu vaccination program delivered 710 vaccinations across all campuses.
- UniSC Sport and Fitness offered gym facilities across the Sunshine Coast, Moreton Bay and Caboolture campuses. SSAF funding also covered registration costs for 139 students who represented UniSC across 11 sports at UniSport Nationals.
- Timely provision of additional emergency relief was provided to students in the form of gift cards, and food bank and hardship grants through the University's Student Wellbeing service.

- Successful Orientation and Connect Week major events were delivered in Semester 1 and 2, with approximately 4,280 new students welcomed in 2023.
- More than 270 students participated in SSAF-funded industry events and workshops
 through the Careers and Employability team's iEngage program, which included
 customised engagement opportunities for student cohorts not previously targeted for
 industry events. Positive feedback from students highlighted increased confidence in
 making career-related decisions and improved knowledge about recruitment practices.
- Twelve strategic Student Engagement campaigns and activities were delivered to proactively connect with commencing students to ease transition and provide just-intime holistic support for continuing students.
 - Students who had successful contact in peer-delivered welcome and onboarding activities were more likely to be enrolled (+6%), had higher GPAs (+0.2) and had higher success rates (+4.4%).
 - Students who had successful contact in engagement campaigns had higher completion rates (between 4 and 60 percentage points, depending on campaign), higher success rates (between 12 and 19 percentage points, depending on campaign), higher GPAs, and lower attrition rates (where applicable).
- The Student Governance Framework delivered a program of engagement opportunities and events across campuses, including 330 active student representatives and 76 meetings across 18 representative groups. The Student Senate collaborated with UniSC Executives to consult on several important plans and strategies, including the UniSC Masterplan and Greenspace Masterplan and the Student Health and Wellbeing Strategy 2021-2023.
